Dear Colleagues, Contributors, Supporters and Friends,

The Light Millennium Organization (LM) has been in the process to "***amending and broadening***" its 2001 Certificate of Incorporation (COI) <http://www.lightmillennium.org/501_c_3/lmtv_form_1023.pdf> along with "***upgrading and strengthening***" its By-Laws. This process began by initially engaging the Volunteer Lawyers Arts who partnered us with an international law firm's New York Office. Since June, 2015 they have provided services on a "***pro-bono***" basis. We are now at the final stage of this process.

Once the COI and By-Laws are APPROVED by the relevant government agencies, the existing ones will be replaced. We will then immediately start working on re-structuring the Organization according to the newly approved Constitution/PURPOSES and begin operating the LM based on the newly approved By-Laws (2018). Consequently, the LM will be conducting a new round of elections for Board of Directors based on the newly APPROVED By-Laws. The current Board of Directors of the Organization has been the longest serving Board of Directors.

Thus, once we've obtained the official APPROVALS, subsequently, we will post both official documents to this site and begin moving towards restructuring the Organization and gaining new and diverse board of directors, supporters/donors, content contributors, volunteers and collaborative institutions in all relevant fields in respect to the new PURPOSES.
